



# Campus Safety and Security Policy for Maryam Abacha American University of Nigeria (MAAUN)

## I. PURPOSE

The purpose of this Campus Safety and Security Policy is to outline the measures taken by the Maryam Abacha American University of Nigeria (MAAUN) to ensure the safety and security of students, faculty, staff, and visitors on campus. The policy addresses emergency procedures, guidelines for reporting incidents, and initiatives to promote a safe and secure campus environment.

## II. SCOPE

This policy applies to all members of the MAAUN community, including students, faculty, staff, administrators and visitors, and covers all university-owned or controlled properties and facilities, as well as university-sponsored activities and events.

## III. POLICY STATEMENTS

1. MAAUN is committed to maintaining a safe and secure campus environment that is conducive to teaching, learning, research, and community engagement.
2. The university will take appropriate measures to protect the physical safety and security of its community members and to safeguard university property and assets.
3. MAAUN will implement and maintain effective emergency preparedness, response, and recovery plans to minimize the impact of emergencies and incidents on the campus community.
4. The university encourages all members of the MAAUN community to take an active role in promoting campus safety and security by reporting suspicious activities, participating in safety and security training, and adhering to university policies and procedures.

## IV. CAMPUS SECURITY MEASURES

1. MAAUN will maintain a professionally trained and equipped security force to patrol the campus, respond to incidents, and enforce university policies and regulations.
2. The university will utilize security technologies, such as access control systems, video surveillance, and emergency notification systems, to enhance campus safety and security.



3. MAAUN will collaborate with local law enforcement and emergency services agencies to address and respond to safety and security concerns and incidents that impact the campus community.

## V. EMERGENCY PROCEDURES

1. The university will develop and maintain comprehensive emergency preparedness, response, and recovery plans to address a range of potential emergencies, including natural disasters, fires, medical emergencies, and incidents of violence.
2. MAAUN will provide training and resources to help students, faculty, and staff understand and respond to emergency situations, including emergency evacuation drills, first aid and CPR training.

2. Reports can be made in person, by phone, or through the university's online reporting system, and can be submitted anonymously if desired.

## VII. EDUCATION AND AWARENESS

1. MAAUN is committed to raising awareness of safety and security issues and promoting a culture of safety on campus through ongoing education, training, and communication efforts.
2. The university will provide safety and security resources and information to students, faculty, and staff, including guidelines for personal safety, crime prevention, and emergency preparedness.
3. MAAUN will continually evaluate and update its safety and security policies, procedures, and initiatives to ensure their effectiveness in maintaining a safe and secure campus environment.
